Interdisciplinarity in the approach to the topic is for us legal science, which is a proven method, method, method of political science, pedagogical science and health science from health and economics. The article by Marcin Skinder draws the readers' attention to the legal issues related to the employment of migrants and the protection of their health. It identifies the problems of employment and health protection of migrant workers, along with limitations and difficulties in accessing the health care system and preventive examinations of foreign workers.

An interesting approach to the subject of otherness in general education was undertaken by Agnieszka Piejka in her work. The author rightly notices that the role of education is to prepare a person for life and meeting otherness: cultural, religious, gender identity, age, disease and disability. The educational process should develop a responsible perception of the Other in a person.

Marcin Płoski, on the other hand, prepared a review of the publication Organizing trade unions in Europe: research and practice edited by Jan Czarzasty and Adam Mrozowicki.

I hope that you will learn with interest the results of our authors' research, and perhaps they will become a starting point for your own reflections.
