

CIMA & University Program fees 2022

1. Students participating in the CIMA & University Program are obliged to pay the following fees:
 - 1.1. a one-off, non-refundable registration fee;
 - 1.2. external exam fees;
 - 1.3. annual subscription fee (if applicable).
2. Timely payment of all fees is the necessary condition of participation and completion of the CIMA Program.
3. All fees paid to AICPA & CIMA are non-refundable and non-transferable between students.
4. All fees are subject to change on 1st January of each year
5. Students of the CIMA & University Program are required to pay the following fees to AICPA & CIMA at each level:

5.1. CIMA & University Program - Certificate in Business Accounting (CIMA Cert BA);

Undergraduate (first-cycle) students of the CIMA Program are exempt from the annual subscription fee for the duration of their Bachelor studies, unless the provisions of the agreement between AICPA & CIMA and the University state otherwise.
