### **Promotion Regulations**

# "1000 EUR Tuition Fee Discount for the Entire Period of Studies for Chosen Programs" Vistula University


### § 1. General Provisions

- 1. These Regulations define the terms, scope, and conditions for participation in the promotion titled: "1000 EUR Tuition Fee Discount for the Entire Period of Studies for Chosen Programs" (hereinafter referred to as the "Promotion").
- 2. The Promotion is organized by Vistula University, headquartered in Warsaw (hereinafter referred to as the "Organizer").
- Participation in the Promotion is voluntary. By participating, the applicant agrees to the terms and conditions outlined in these Regulations.
- 4. Eligible participants are individuals who meet all the criteria specified in §2 of these Regulations.
- 5. The Promotion is valid from June 25, 2025, to July 31, 2025.

### § 2. Participation Criteria and Promotion Details

- The Promotion is open to new students applying to Bachelor's or Master's degree programs conducted in English in the following fields:
- Finance and Accounting with ACCA
- Management (Polish-British Double Diploma Program: Vistula University and **London South Bank University)**
- 2. To qualify for the Promotion, candidates must:
- Be citizens of countries located in the following regions: Africa, Americas, Asia (except Central Asia, Armenia, Azerbaijan, Georgia and Mongolia) Southern Europe (except EU countries) and Oceania.
- Submit a complete set of required application documents.
- Apply for studies starting in the Fall semester of the 2025/2026 academic year.
- Pay the full annual tuition fee no later than July 31, 2025.
- Not be transferring into higher semesters of study.

- 3. Participants meeting the above conditions will receive a 1000 EUR discount on the tuition fee for the first academic year of their studies.
- 4. In order to maintain the discount for each subsequent academic year of the program, participants must achieve a minimum Grade Point Average (GPA) of 4.4 or higher at the end of each academic year.
- 5. The discount will be renewed annually by the Bursar's Office at the request of the Promotion participant, provided the required GPA has been confirmed. If the GPA condition is not met in any academic year, the participant will lose the right to receive the discount for subsequent years.
- 6. All classes covered under this Promotion will be conducted in Warsaw.
- 7. The Promotion does not cover expenses related to accommodation, meals, transportation, or any other fees outside the tuition fee.
- 8. Participants who do not commence studies in the Fall semester 2025/2026 or who withdraw from the program at any point will forfeit their right to further discounts under this Promotion.
- 9. This Promotion cannot be combined with any other discounts, scholarships, or promotions offered by Vistula University or Vistula School of Hospitality.
- 10. The Organizer's designated personnel will oversee the execution of the Promotion and provide support for any questions or concerns regarding these Regulations.


#### § 3. Complaints Procedure

- Complaints related to the Promotion must be submitted in writing to the Organizer's official address.
- 2. A written complaint must include the applicant's full name, postal address, and a detailed explanation of the complaint and its basis.
- 3. Complaints will be reviewed and resolved within 14 days of receipt.
- 4. The Organizer's decision regarding the complaint is final and binding.

#### § 4. Final Provisions

- 1. These Regulations are available on the official website: www.vistula.edu.pl and at the University's Recruitment Office.
- 2. The Organizer reserves the right to amend these Regulations, provided that such changes do not affect the rights already acquired by Participants. Any amendments will be announced in advance on the website mentioned in section 1.
- 3. Acceptance of these Regulations is equivalent to the Participant's consent to the processing of their personal data by the Organizer in accordance with the General Data Protection Regulation (EU) 2016/679 (GDPR) for the purpose of administering the Promotion. The Organizer is the data controller of all personal data submitted as part of this Promotion.
- 4. Participants have the right to access, update, and correct their personal data.
- 5. Any disputes related to this Promotion will be resolved amicably. If amicable resolution is not possible, the dispute shall be settled by the court with jurisdiction over the Organizer's registered office.
- 6. In matters not governed by these Regulations, the provisions of Polish law shall apply. All materials derived from these Regulations are for informational purposes only.
